Fighting Monsanto in 2011

The Center for Food Safety (CFS) is an organization monitoring the vast resource of food production and supply for our safety. The public is in part updated by videos from Michael Pollan and Vandana Shiva on CFS's work to protect our food, families, farms and communities.

CFS has had numerous legal victories in 2010 in protecting us from legislation that would pass laws and regulate what would end up as what we eat and feed our families. Although Monsanto, a powerful organization that is continuously working against good farming and good food sources, with its biotech allies continue to challenge CFS's successful victories of banning the sale and planting of GMO alfalfa, bentgrass, wheat, sugar beets and biopharmaceutical crops.

During the holidays last month CFS's staff attorneys worked daily to defeat these legal attempts to overturn recent victories. CFS is preparing for new legal challenges as the FDA is poised to approve GMO salmon. Additional challenges are coming with the USDA considering approval of Dow's 2,4-D tolerant corn and Monsanto's Dicamba tolerant soybeans.

This is a serious issue as approval of gene altered salmon could threaten the very survival of native salmon species in Canada and the U.S.. These new herbicide promoting crops would result in more millions of pounds of toxic chemicals dumped in our fields and foods, which would end up in our bodies and our children's bodies.

There are these and other critical efforts ahead of us in the coming year, so please keep updated so you can contact appropriate agencies and to know what CFS is doing to protect us. There are many areas where the CFS fails in effectively watching and fighting for our food safety.

We need to protect true organic farms and farmers and our entire food supply while holding the government and biotechnology companies such as Monsanto accountable for their actions.

CFS won a major lawsuit against USDA, Monsanto, and a number of other biotech companies last August, and as a result of that victory the planting and sale of GMO sugar beets is now also illegal.

Last month CFS obtained a win in the courts, as a federal judge ordered that GMO sugar beets that were illegally planted "be destroyed". This was the first time ever that a court has ordered the destruction of a GMO crop.

As you might imagine, with their profits on the line with recent defeats, Monsanto and other biotech companies are fighting back and have ramped up their efforts in these legal battles. Using their political influence, they were able to take the alfalfa victory all the way up to the Supreme Court, which while exciting and precedent setting, put a tremendous burden on CFS financially. Now Monsanto is also challenging the successful sugar beet victory, and using all their power, finances and political will to appeal this case.



Many are and have been saying that Monsanto is another power hungry beast that has emerged and grown into a globally dangerous operation that does not have your best interests in mind. In fact, its to the point that if Monsanto is for something, then farmers and anyone with the slightest concern for health should beware and against it actively. 🗨️

Lucille wrote to us about recent experiences and said, "last Saturday I applied the sequence for extraction to our churchmate, a lady who fell on her face when she lost her balance. It was in the middle of a wedding ceremony. I quickly placed my left hand on her

face, that hit the floor, and right hand on top of the left hand for about fifteen minutes. She felt better and she was amazed because there was no swelling or bruising.

I also applied the stop bleeding and seal (S&S) procedure on my thumb that I cut while I was cutting up some string beans. The blood did not drip and the wound sealed!

This morning, after our Dawn Worship service in church, one elderly lady complained of dizziness. So I embraced her thumbs for fifteen minutes, and she felt completely well again.

I also applied the extraction procedure to an Australian woman who met with an accident in a grocery store. The escalator suddenly stopped causing her grocery cart to hit her in the head. The paramedics in the store went to get ice. This took some time and so I applied TKM® on her while she waited for them to come back. She was very thankful and I prayed for her because it was also her 70th birthday.

I also applied the stop bleeding procedure to a student of a music teacher that I interviewed. After the interview, my cameraman asked me to help a boy in the restroom whose nose was bleeding. It only took seconds and the bleeding was stopped.

I Can't help it but to share and apply TKM® when the need arises."

I know of many other TKM® stories that Lucille has, but this should provide some incite into her heart and active responses to needs, as I also know there are many of you that reach out as a lifestyle to help when someone is in need.
